

**BANK STREET COLLEGE of EDUCATION
DEFERRED PAYMENT AGREEMENT FOR TUITION AND FEES FOR SPRING 2007 SEMESTER**

(A deferred payment plan cannot be granted to a student whose previous financial credit record is unsatisfactory)

There will be a fee of \$20.00 charged for processing this deferment.

Total tuition and fees for each of the Fall and Spring semesters may be payable in four approximately equal installments within each respective semester; 25% payable at the time you register and 25% monthly thereafter as indicated below.

There is no finance charge to your account when payments are received in the College's Business Office in accordance with the payment schedule. A FINANCE CHARGE OF 1-1/3% PER MONTH(16% ANNUAL RATE) will be imposed on any payment, or portion thereof, not received in the College's Business Office (Room 712) by the due date.

Students will not receive transcripts or be eligible for registration if they have not fulfilled their financial commitment and cleared their library record. All charges must be paid before a diploma is issued or a degree conferred.
